ii) Ditches and blocked culverts at the entrance to Olive Farm and other properties. HH undertook to follow this up with John Nicholson (JN) of Highways, some feedback received but problems are still existing! Concerns raised regarding contaminated water & consequent high levels of E-coli. JN discussing urgency for pipe replacement with new contractors.

SH to request another meeting with JN, to include HH & PS & discuss action for potholes and signs for NO speeding in the village. Additional traffic flow presumed to be impacting on the road surface, reduce the speeding cars reduce the potholes. Photograph any damage and report to council.
