1) Matters Arising

- i) Local Government Boundary Commission no update received.
- ii) River Cary & Environment Agency Watercourse, ongoing.
 - Reply from EA received which provides no reassurance.
- iii) General village maintenance update, junction at Olive Farm lettering on road has will be repainted in the spring. A new horse warning sign has been put up at the A37 entry into the village.
 - SH in discussions with Highways re reflectors along Babcarry Lane by Deer Park Farm.
- iv) Babcarry Website, PS looking for more comparison quotes, agreed to revisit next parish meeting, PS still awaiting feedback from second parties.
- v) Mrs Goymer attended meeting to discuss these matters in person. Her initial concerns focused on the premature opening of the bonfire site and the types of materials being deposited and the threat to wildlife. The pallets in question were inspected and found suitable for burning.
 - The Parish Council has agreed to forward a number of recommendations to the Playing Field Committee (PFC) regarding preparations for next year's Village Bonfire. These include measures to help deter fly tipping, such as securing the Playing Field, providing clear guidance on what materials are appropriate for burning, and considering the installation of CCTV and a padlock on the gate.
 - The PFC was recommended to arrange for the removal of accumulated detritus from previous bonfire events and it was suggested that a meeting of the PFC be convened before the end of 2025 to address these matters in more detail.
- vi) Playing field gate made easier to open & close by PS, JT offered her thanks.
